Announcements	Issue	DEV-1691	Increased the character count for Announcement text and voice from 459 characters to 918 characters. Administrators can now create long text and voice messages when creating a new announcement.
	Issue	DEV-1683	Addressed the issue with Spell check. We've added the spell check ability for announcements, events, service request, security logs, incident reports.
Group Permissions	Issue	DEV-1987	<p>Our Group Permissions model has been revised to be more streamlined and better organized. We have introduced the concept of "staff" versus "resident" for all groups; going forward, when creating a new group you will be required to select either the "staff" or "resident" group type. For the staff group type, all permissions are available, while for residents, a limited set of options will be available. Permission options are now neatly categorized making it much easier to make selections within each category. We have removed the global "Can change admin settings" option and replaced it with more detailed and specific permissions.</p> <p>You can view the new groups configuration page and make changes by clicking your name in the upper-right corner, selecting Setup, then Groups.</p>
Email	Issue	Dev-1628	Addressed the issue with workspace name not showing up on the email notification for administrators. This issue impacted administrators who belonged to multiple workspaces. We've added workspace names to all email subject lines to provide better information about the email notification.
	Improvement	PR-135	Added the ability to customize package notification email for residents. We've received multiple requests from administrators to have the ability to customize the package notifications for individual workspace. Please contact support if you would like us to change the email content for your package notifications.
Reporting	Issue	DEV-1718	Addressed an issue with new reporting functionality. We have now added permissions to individual reports. Each report will need a set to permissions to be visible on the reporting section. Please contact support for more information on reports and permission changes
Stripe	Issue	DEV-1698	Added the ability to restrict permissions for creating new stripe account for staff users.
Security & Concierge	Improvement	PR-125	Added the ability to capture signature when registering new visitors.
