Announcements	Issue	DEV-1731	Addressed an issue with announcement multiple file upload feature. This issue impacted a few users when they uploaded multiple files during the announcement creating process and later edited the announcement with a different set of documents.
	Issue	DEV-1757	Wording clarification on announcement create new page. We've received multiple questions about the existing wording for Text and voice announcement feature that involves sending messages to users with an email address. We now introduced radio buttons with clear instructions on how the functionality works.
Electronic Consent for legal documents	Improvement	PR-573	Added the ability to capture electronic consent for residents using Condo control central. We have received multiple requests from our users to introduce functionality that will help them capture consent for delivering documents electronically. As part of this change, we have introduced Electronic consent setup process under the setup section> Workspace settings. We made changes to the unit file (User and unit pages), announcement feature and also reporting functionality. By default, this functionality is turned off for all users. In order to switch on the functionality, administrators will need to follow these steps: Setup > Workspace settings> Electronic consent> Turn on. By default, the "Owners" group are selected as the members.
Events	Issue	DEV-1724	Addressed an issue with email calendar invitation for Gmail users. This impacted few Gmail users who had a different time showing on the calendar invitation to the email details.
Discussion Forum & Classified Ads	Issue	DEV-1723	Added the ability to create new threads for the Discussion forum and Classified ads without the need for approval. Administrators can update moderation settings on the setup page> Discussion forum & Classified Ads> Select Moderation group.
	Issue	DEV-1728	Administrators now have the ability to add Terms and conditions on the discussion forum create new page. This function will work similar to Service request instructions. Users will see the instructions when creating a new post on the Discussion forum and Classified Ads pages.
	Issue	DEV-1736	Addressed an issue with moderation emails not being sent for updates made by residents after the initial post has been approved. Administrators from multiple workspaces wanted an update email after approving the initial post.
Purchase Order	Issue	DEV-1777	Addressed an issue with Purchase Order approval process default setting. Administrators in a few workspaces received an error message when processing their first Purchase order, this error was caused due to an error in configuration on the setup page for the default approval process.
Reporting	Improvement	PR- 143	As part of our transition from old to new reports, we have implemented new reporting functionality for Service request, Tasks, Amenity booking and Electronic consent.

Service request	Improvement	DEV-1742	Service Requests have undergone a few important changes:  1) We now allow for "public" and "internal" comments. Public comments operate as usual, and are visible to the owner/resident requestor. "Internal" comments are visible only to the management team and will not be sent to the requestor.  2) You now have the option to close requests without being required to enter a comment. This needs to be turned on under "Setup > Service Requests".  3) The user interface around updating & closing a request has been simplified. The status, follow up frequency, and update button have been combined into one button. Let us know what you think.
Tasks	Issue	DEV-1748	Addressed an issue with Tasks print option. Few users reported experiencing blank pages printing for some of the task reports.
