<b>File Library</b>			
	Issue	DEV-1375	Addressed an issue with File library delete option. This issue occurred in certain situations when the user belonged to multiple workspace and tried deleting a file in the Library.
<b>Maintenance</b>			
	Issue	DEV 1278	Addressed an issue in the maintenance module with the "Do not re-schedule" option. This issue occurred when users selected the "This is the last time, Do not schedule it again" option on the "Mark Activity As Completed" page.

	Improvement	PR-419	Added support for USB Topaz signature pad. You can now use Topaz signature devices to capture signature while releasing packages, keys and authorizations.
	Issue	DEV 1377	Addressed an issue with Incident report "Out of office" auto reply updates. This issue occurred when administrators have an automated email reply set for "Out of office" causing a loop between CCC and their email program.

	Issue	DEV 974	Addressed an issue with Service request re-assigned feature. The issue occurred in certain situations when the users do not belong to Property Management group and would not be notified of the reassignment.

	Improvement	PR-302	Added a new feature to track users who have unsubscribed from email notifications. Now Property manager can generate a report to track unsubscribed users. We also added a new email permission setting to notify the administrators about the unsubscribed users. Administrators can also resubscribe residents if they have obtained permission to do so.
