Consent Document Signing	Improvement	PR-793	Based on client requests, we added the functionality to gather consent for any legal documents. With our consent document signing feature administrators can upload their customized document and easily gather consent. Our system sends multichannel reminder notices to users requesting their consent for the document. Users will be notified by email, text, voice and during system login.
Push notifications	Improvement	DEV-2018	Addressed an issue with Andriod Push notifications. This issue is currently fixed for Andriod users. Our goal is to have push notifications improvements rolled out for IOS by December 10th.
Purchase Order	Issue	DEV-2125	Addressed an issue with Purchase order validation. Errors for fields missing, required information.
	Issue	DEV-1973	Addressed an issue with purchase order quantity field validation message for Draft purchase order.
	Improvement	PR-776	Updated Purchase order download version. Based on client feedback, both portrait and landscape print version of the purchase order has been updated.
Print Job	Issue	DEV-2145	Addressed an issue with Print job functionality for the supplier. The resident list file download required extra permissions that blocked the supplier from downloading the list.
Reporting	Issue	PR-799	Addressed an issue with Board the meeting report. Based on client feedback, the new report is closely matched with the old reporting functionality.
	Issue	DEV-2160	Addressed an issue with the User login report. Due to the large volume of data, the report crashed for certain workspaces.
Registration documents	Issue	DEV-2009	Addressed an issue with documents signed by non-electronic consent groups. This issue happened for workspaces where non-electronic consent groups had forms to sign during the registration process. These documents were unavailable to be viewed on My account and Unit file due to a permission issue. We now corrected the permissions to allow the administrator to review these documents.
Status certificate	Issue	DEV-2020	Addressed an issue with status certificate confirmation message when the credit card transaction fails. We have identified two situations where users had their transaction declined due to CVC problems and the Charge failed situation that results in errors.

	Issue	DEV-2115	Addressed an issue with status certificate email confirmation. All users received our default template for status certificate 10 days delivery. This issue affected users who choose the speedy service and still received the default 10 days turnaround time.
Service request	Issue	PR-795	Addressed an issue with service request email preference. Administrators who had their service request create and update email permissions turned off were receiving the email reminders. This issue should now be resolved.
Unit File	Issue	DEV-1127	Added the ability to delete units. Based on client feedback, administrators now have the option to delete units. Users can delete the unit by clicking on the Unit > Unit details> Delete button. Please note, users can delete a unit when there are no users linked to the unit.
	Improvement	PR-717	Added the ability to create user notes. As part of this change, we have introduced important notes. Administrators can now add important notes to units and users. When an important note is added to a user/unit, the system will show an attention icon for administrators to see the note information on the unit file list page, Unit details page, User details page and global search details.
